

WARRANTY

Products manufactured by Caddy Corporation of America are warranted to the original purchaser to be free from defects in material and workmanship under normal use, storage and service for a period of one year from the date of shipment.

Electric components are warranted for a period of ninety days from the date of shipment or the period of warranty extended to us from the original manufacturer, whichever period shall expire last

Caddy Corporation of America shall repair or replace, at its option, without charge any part or product which our examination discloses to be thus defective.

Under no circumstances will Caddy Corporation of America honor any repair or backcharges by any party regardless of whether such equipment is within the warranty period, unless such work has been authorized in writing by the Service Department of Caddy Corporation of America.

If the equipment is repaired or altered in any way whatsoever by any person without prior written consent by Caddy Corporation of America, this warranty shall not apply.

Normal wear parts, such as pilot bulbs, gaskets, etc., are not covered by this warranty.

This warranty shall not apply to defects or damages resulting from accidents, alterations, abuse or misuse of equipment and/or any of its component parts, nor shall it apply to damage of electric components resulting from connecting the equipment to any power supply other than specified on the nameplate or resulting from unauthorized altering any of the electric components and/or control equipment not traceable to component defects, nor from faulty workmanship done by others, nor use of materials containing components harmful to materials used in the manufacture of Caddy products.

There is no other express warranty.

Any and all implied warranties are excluded to the extent permitted by law. Implied warranties, when included by law, including those of merchantability and fitness for a particular purpose, are limited to one year from the date of shipment.

Liability for consequential damages under any and all warranties are excluded. This warranty is the buyer's exclusive remedy.

WARRANTY A

(This warranty is complete and does not include any part of the standard Caddy warranty.)

Not manufactured by Caddy Corporation of America. Manufacturer's warranty is available upon request.

WARRANTY B

(This warranty covers the refrigeration unit only and the standard Caddy warranty covers all other parts of this equipment.)

Refrigeration unit is not manufactured by Caddy Corporation of America. Manufacturer's warranty is available upon request and states: "Replacement of compressor unit anytime within 20 months of installation at no charge. (Labor for removal and re-installation of new unit is not included. Freight of defective unit to and from factory is not included.) Other parts of refrigeration system with factory warranties will be replaced within one (1) year of installation. Labor or freight charges are not included."
